Proceedings:		

- 1. The proceedings of the previous meeting dated  $21^{st}$  of January 2016 were read, and confirmed.
- 2. Issues arising out of the previous meeting:

## The members expressed happiness over the fact that the chamber made available to the Secretary of was of good quality.

- 3. The Budget of the college for the financial year 2016-17 was presented by the Principal, and was approved unanimously.
- 4. (a) The Audit Report of the College for the financial year 2015-16 was presented by the principal, was discussed in detail, and was approved unanimously.
  - (b) The application of the Chartered Accountant Sri K. K. Harodia for fee hike was considered and it was decided to raise his fee to Rs. 10,000/- per quarter.
- 5. The Principal presented a detailed report about the latest development of RUSA activities; and it was reported that the college had already submitted a) the utilization certificate of the first lot of RUSA grant and b) the detailed and final D.P.R. of the construction project of the college was submitted to the authorities in time. It was expected that the construction project would be started soon.

- 6. After weighing all pros and cons regarding continuance of the B.Ed. course in the college, it was decided unanimously not to apply for the affiliation and recognition of the two-year B.Ed. course in the college any further. It was decided to stop teaching B.Ed. in the College.
- 7. The application of the eleven members of the college staff working on management post so far that they be paid salary etc. in the 6<sup>th</sup> pay scale could not be not considered. Last time, they were given a raise in February 2015, and it was decided not to consider any request for raise in salary etc. for a period of two years. It was decided to consider any application of raise in remuneration only after February 2017.
- 8. Miscellaneous:
  - (a) It was decided to regularize the service Sri Sujit Kumar Mahto, the gardener of the college working in the Bhuda campus (Boys' wing) w.e.f. July 2016.
  - (b) The Principal reported about the case of "dereliction of duty" and "indiscipline" of Sri Prabhat Kumar, Assistant Professor, Department of English. All the members were concerned; and the Principal was authorized to take steps which are deemed necessary.

The meeting ended with a vote of thanks to the chair.
