

A meeting of the Guru Nanak College Governing Council was held today, Tuesday 09th May 2023 in the Bhada Campus of the college. Sardar R.S. Chahal, President was in the chair. The following members were present:

Proceedings:

1. The Proceedings of the previous meeting dt. 21st April 2023 were read and confirmed.
2. Issues arising out of the previous meeting:
 - a. As decided, Sri. Preeti Mandal, Lawyer represented the college and appeared before the Assistant Labour Commissioner Court on 22.04.2023 with all relevant documents relating to retiral benefit, and made the stand of the college clear. He apprised the Court that the college had already paid retiral benefits to the complainants, who

were working at management posts, under provisions.

3. The letter dt. 02.05.2023 sent by Sri. Prabhat Kumar to the college was placed before the G.B. Through this letter and in view of order dt. 28.02.2023 passed by the Honorable High Court of Chhattisgarh in the W.P. (S) No. 6249 of 2019, he made a request to join the college.

The Secretary of the college apprised the council about the decision taken by the G.B. in its emergent meeting dt. 20.04.23, "----- that a punishment of removal from service is taken which would not affect the future employment of Sri. Prabhat Kumar", and also the same has been communicated to the Chhattisgarh Public Service Commission, Raipur for necessary approval. Also, letter has been sent to Sri. Prabhat Kumar about his removal from the service.

4. The Selection Committee meeting - for the interview and appointment of the Principal - was held on 2nd May 2023 at 9.30 am in the Bhuda campus of the college. The President of the college, S. R. S. Chahal was the chairman of the Selection Committee. The other members were S. Diljann Singh Grewal, Secretary and the three experts, Dr. Kashvir Singh, Professor and chairperson, Department of Bio-Technology and Co-Ordinate DST-Centre for policy research, Punjab University, Chandigarh, Dr. G. B. Kanaraiah, Professor Department of Economics,

FSS- Banaras Hindu University, Varanasi and Dr. Rajesh Pal, Professor and former Head, Department of Economics, Mahatma Gandhi Kashi Vidyapeeth, Varanasi

The Selection Committee was apprised about the number of applications received for the post of the Principal. They were apprised that out of the three (03) applications received, only two were found valid. The interview letter was sent to only these two applicants. The Selection Committee waited for some time and started the interview. Only one applicant, Dr. Sanjay Prasad, Associate Professor, Department of Economics, Gyan Nandan College, Dharwad and Acting Principal of the College appeared and was interviewed. The panel was prepared with the single name of Dr. Sanjay Prasad, duly signed by the chairman of the Selection Committee, S. R. S. Chahal, S. Diljant Singh Grewal, and the experts present, Dr. Kashish Singh, Dr. J. B. Komarish and Dr. Rajesh Pal.

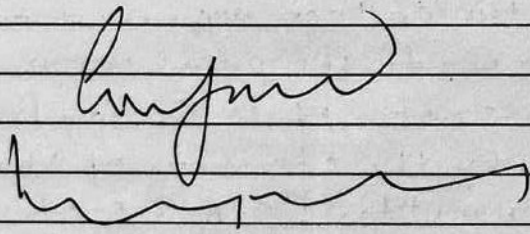

5. The matter of vacant land in front of and behind the Bhuda campus of the college came up for discussion.

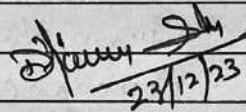
