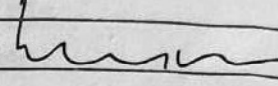
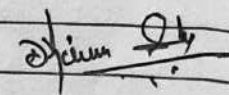
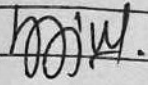
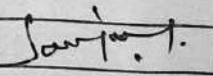


A meeting of the Gurm Nanak College Governing Council was held today, Saturday 23rd December 2023 in the Women's Wing premises of the college at 3:00 pm. Sardar A.S. Chahal, President of the College was in the chair. The following members were present:

Proceedings:

1. The Proceedings of the previous meeting dated 09.05.2023 were read and confirmed.
2. Issues arising out of the previous meeting:
 - a) It was informed by the Secretary that appointment letter had been issued to Dr. Sanjay Prasad as Principal of the College vide letter no GNC/PW/2023/41 dated 10/05/2023. He also informed that Dr. Sanjay Prasad had joined as principal of the college.

- b) The Secretary and the Principal informed the governing council that as per the plan the construction work on the third floor of the vocational building got started from August 2023 and civil work is going on.
3. The progress of construction work on the 3rd floor of the vocational building came up for discussion. The Principal apprised the members of governing council that construction work has reached up to roof casting; within a weeks time, roof casting will be completed.

The Secretary and the Principal were authorised to finalise the following items and work in consultation with the President:

As this necessary sanction has been granted by the governing council.

4. The Secretary and the Principal apprised the members of the governing council that the case filed by five retired non-teaching staff against college in the labour court for non-payment of gratuity, Pension etc. is still going on. Earlier, in the labour court both the parties appeared and submitted documents from college side. Sri. Pinte Mondal, Advocate, appeared. The details submitted by the lawyer was placed before the governing council.

5. The Audit Report for the financial year 2022-23 was placed before the governing council. After going through it in detail, the audit report was approved unanimously.

6. A meeting with one auditor, Sri. K. K. Harodia was convened to discuss the matter of number of accounts/funds; how to close some of them. The meeting was attended by the President, SRS Chahal, Secretary, S.D.S. Gmeval, Principal, Dr. Sanjay Prasad and Bursar, Prof. Sanjay Kumar Sinha. Mr. Harodia suggested to close some of the accounts after final audit for the financial year 2023-24 is completed.

8. The Principal informed the members of governing council about the admission status of BCA and BBA programme. He told that in the BCA programme the number of enrollments has touched 94 in the current academic session (2023-24) compared to 60 in the last year; whereas in BBA the enrollment figure has touched 70 compared to 10 in the last year. Everyone expressed happiness on this grand development.

The Principal also apprised members of the governing council that from academic session 2023 admission to Intermediate course, P.A. and L.com has been stopped as per university notification.

9. The Principal presented a report on the Punjab trip. Our cultural team went to Punjab and performed through dance and music in the three universities, a) Punjabi University, Patiala b) Punjab University, Chandigarh c) Guru Nanak Dev University, Amritsar under cultural exchange programme between 13th September 2023 and 20th September 2023.

He happily informed the members of the governing council that for the first time College Cultural team performed in this fashion in some of the renowned universities of our Country. The performances of our boys and girls were applauded by one and all in all three universities.

The tour programme, schedule and dates of performances were finalised by the President, S.R.S. Chahal, Secretary S.D.S. Grewal and the Principal Dr. Sanjay Prasad. Altogether, 24 Students (Boys and Girls) and 03 accompanists were part of the cultural team led by Team In-charge, Dr. Mina Malkhandi and Prof. Baljit Singh, co-In-charge. It was a very successful tour.

In all, a sum of Rs 7,36,389/- was spent on the Punjab trip - cultural Exchange programme in the three universities of Punjab. The governing council has approved the total expenses incurred on the above.

The Principal apprised members of the governing council that Ms. Nishtha Sand had covered the whole programme in the three universities of Punjab. Whereas Ms. Sukhmit Chahal had given her valuable contribution in preparing the College Cultural team. Everyone present in the meeting expressed happiness on the grand performance of our cultural team.

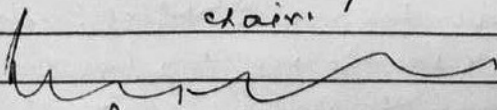

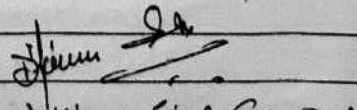
