A meeting of the Governing Body of Guru Nanak College, Dhanbad, was held on 3rd November 2025 at 10:30 AM at the Women's Wing Campus. The meeting was chaired by the President of the Governing Body, Sardar R.S. Chahal and following members were present:

Proceedings:

1. The proceedings of the previous meeting held on 4th July 2025 were read and confirmed unanimously by the members present.
2. The matter of tax exemption was discussed. Appropriate follow-up actions were reported as discussed in the previous meeting.
3. The issue regarding the suspension of Dr. Sanjay Prasad was deliberated. It was resolved to constitute a new Enquiry Committee for unbiased treatment of the matter, comprising the following members:
 - Sardar Manjeet Singh, Patherdih (Chairman)
 - Sardar Manjeet Singh Saluja, Secretary, GNC (Member)
 - Sardar Harwinder Singh, Secretary, Khalsa High School (Member)
 - Dr. Ranjana Das, Principal (Member)

It was decided that the newly formed committee will hold meetings, go through all the papers and come to a justified conclusion in 12 weeks / 90 days.

4. The matter of Gymnasium was taken up and it was decided to restart the Gym with trainers for men and women. It was decided that if the Gym is not revived in the next six months it may be disposed off.
5. It was noted that Sixty Percent of books have been bought for the library based on the budget approved in the previous meeting for the procurement of new books and journals.
6. The matter of introducing new vocational courses, including B. Lib., MBA, MCA, Courses in French and German, was discussed. It was reported that all the proposals have been submitted at the University for Approval. The council decided that the construction of infrastructure for housing new courses will begin after approval from the Academic Council of BBMKU.
7. The Governing Council approved the construction of Boys' Common Room in the Vocational Block.
8. Prof. P. Shekhar advised that all the teachers must be instructed on teaching methods through smart technology by conducting workshops. It was decided to organize these workshops for the betterment of teachers and students.
9. The closure of an account related to Vocational Courses at Union Bank of India was confirmed.
10. The setup of new CCTV Cameras and additional storage capacity at Bank More Campus was approved.
11. The purchase of four new computers and repair of existing computers were approved.
12. The proposal of upgrading College Website was approved.
13. The AMC was approved.

There being no other matters to discuss, the meeting concluded with a vote of thanks to the Chair.
