A meeting of the Governing Body of Guru Nanak College, Dhanbad, was held on 4th July 2025 at 10:30 AM at the Women's Wing Campus. The meeting was chaired by the President of the Governing Body, Sardar R.S. Chahal and following members were present:

Proceedings:

1. The proceedings of the previous ordinary meeting held on 25.01.2025 and the emergent meeting held on 05.05.2025 were read and confirmed unanimously by the members present.
2. The matter of tax exemption was discussed. Appropriate follow-up actions were advised as per applicable procedures.
3. The issue regarding the suspension of Dr. Sanjay Prasad was deliberated. It was resolved to constitute an Enquiry Committee comprising the following members:
 - Sardar R S Chahal (Chairman)
 - Prof. P. Shekhar (Member)
 - Sardar D. S. Grewal, Secretary (Member)
 - Sardar G S Manjha, President, GPC (Member)
 - Sardar Tejpal Singh, Secretary GPC (Member)
 - Dr. Ranjana Das, Principal (Member)
4. The Governing Body approved the proposal of the Principal for the regularization of four non-teaching staff members against sanctioned posts due to retirement vacancies:
 - Shri Ranjit Kumar Mishra (against the post vacated by Shri Murlidharan S., retired on 31.05.2014)
 - Shri Amandeep (against the post vacated by Shri M.H. Ansari, retired on 31.01.2017)
 - Shri Narender Singh (against the post vacated by Shri Anant Mohan Singh, retired on 31.01.2019)
 - Shri Pankaj Kumar Prasad (against the post vacated by Shri Inderdeo Singh, retired on 31.05.2023)Approval was granted to proceed with necessary formalities.

5. Based on the proposal of the Principal, the Governing Body approved the enhancement of remuneration for part-time teachers (engaged on a per-class basis) from ₹250 to ₹500 per class, with a monthly ceiling of ₹16,000 w.e.f. August 2025.

6. The following pay revisions for Vocational Faculty were approved w.e.f. August 2025:

- Prof. Mamta Prasad – from ₹24,000 to ₹28,000 per month
- Prof. Anshuman Saha – to be placed on a consolidated monthly pay of ₹24,000

7. The proposal submitted by Ms. Sadhna Kumari Singh, Department of Economics, to organize a National Seminar titled “*Jharkhand@25: Celebrating 25 Years of Statehood and 150th Year of Janjaatiya Gaurav*” sponsored by JSHEC was discussed. The President suggested inviting the Honourable Chief Minister, Shri Hemant Soren, as the Chief Guest. Necessary steps were approved to be initiated in this regard.

8. The requirement for repairs to the dome and boundary wall of the Bhuda Campus was reviewed. The proposal of the Principal was approved as a necessary safety measure.

9. The Governing Body approved the shifting of the gymnasium from the Bank More Campus to the Bhuda Campus for better resource utilization. It was also decided to convert the vacated gymnasium space at Bank More into a classroom.

10. A budget of ₹1.5 lakh was sanctioned for the procurement of new books and journals in the college library.

11. All deficiencies related to AICTE affiliation were discussed in detail. Prof. Uday K. Sinha was entrusted with preparing a comprehensive proposal to address the same.


12. The proposal to introduce new vocational courses, including MBA and MCA, was discussed. Prof. Uday K. Sinha was tasked with preparing the necessary proposals.

13. The Secretary suggested converting the current waiting lounge area in the vocational block into a Boys' Common Room. The proposal was accepted.

14. Prof. P. Shekhar advised that upon AICTE approval of new courses, BCA and MCA should be housed in the Bank More Vocational Block, while BBA and MBA programs should be shifted to the Bhuda Campus.

There being no other matters to discuss, the meeting concluded with a vote of thanks to the Chair.
