Proceedings: -

1. The Proceedings of the previous meeting were read and confirmed.

2. Conduct of Jharkhand Staff Selection Commission (JSSC) Examinations

The Principal informed the members that three examinations conducted by the Jharkhand Staff Selection Commission (JSSC) were scheduled on three consecutive Sundays during the month of April. Examination-related responsibilities were discussed in detail, and duties were assigned to the concerned teaching and non-teaching staff members. Signatures of the assigned personnel were obtained in the examination duty register as a token of acceptance of their respective duties.

The Principal also briefed the members on the rules, regulations, and guidelines governing the conduct of JSSC and Jharkhand Public Service Commission (JPSC) examinations. Detailed instructions relating to examination protocols, bell timings, invigilation procedures, reporting schedules, and other operational aspects were explained to ensure the smooth and fair conduct of the examinations.

3. Approval of Academic Courses

The Principal informed the Staff Council that four academic courses had been duly approved by the BBMKU Academic Council. The members were apprised of the approval, and the concerned departments were advised to take the necessary steps for their effective implementation in accordance with the prescribed academic regulations.

4. Minimum Attendance Requirement for Formation of Classes

The Council discussed the minimum student strength required for conducting classes. It was resolved that a class shall be conducted only when a minimum of ten (10) students are enrolled and present. In cases where the student strength is less than ten, the concerned class shall not be conducted until the prescribed minimum requirement is fulfilled.
